Our Town Roads

Every year around this time, I like to reflect on why I ran for a position on the Town Board, and what our priorities should fundamentally consist of. I've been a resident of the Town of Cedarburg all my life, and have witnessed its growth from a modest township into the thriving place I still call my home. I wanted to serve on the Town Board because it is the keystone that bridges public interest and civic sustainability in our Town. We work to address concerns and seek strategic change. By doing so, our Board searches for facets of Town infrastructure that may need an update or renovation based on economic considerations, and as a response to the many wonderful and vocal citizens in our Town who advocate for the betterment of our Town, many of whom I'm fortunate enough to know personally.

As a member of the Town Board, one of my biggest priorities each year is to help guide the implementation of a fair and effective tax bill. For the past 12 years, the Town's property tax levy has grown as a reflection of the Town's prosperity, evaluated mainly thru the Town's assessed value. Meanwhile, demand for civil projects and Town maintenance has been relatively low, allowing for the Town portion of our tax bill to remain fixed for more than a decade. As many of you are aware, the resident's annual tax bill is divided into 5 categories: 61% Cedarburg schools, 15% Town, 14% County, 9% MATC, and 1% State. After a thorough review of the Town's overall condition, a budget for this year was produced by our exceptional Town staff consisting of Tim Rhode, Eric Ryer, Adam Monticelli, Jeff Boerner, Charlie Pretty, and Paul Jungbauer. A highlight of this year's budget is that it will necessitate a Town tax levy increase of 2.96% to offset the cost for much-needed road construction.

Many of our Town roads hold up to standards, but not all of them. Our Town Board has received a number of concerns regarding stretches of road that may be deemed unsafe, especially as our roads continue to wear throughout the years. The Midwest is notorious for this. During recent seasons, climates have been particularly tumultuous, with temperatures sometimes climbing or falling 30 degrees in just a single day. Expansion and contraction are inevitable and introduce both immediate and anticipatory hurdles for safe transportation infrastructure. We want to nip this issue in the bud before it leads to serious safety concerns and traffic congestion down the line.

We are very pleased to have Jeff Boerner as our new Public Works Director. Jeff became our Public Works Director in January of this year. Jeff has been with the Town for four years as the Foreman after being with the City of Cedarburg for 29 years, 13 of which serving in the role of Superintendent. He brings with him a breadth of knowledge and experience that sets him up for success. He has strong roots in the Cedarburg community, including being an active member on the Cedarburg Fire Department.

With Director Boerner at the helm, the Town promoted from within its ranks Joey Hintz as our Department of Public Works Crew Foreman. Joey has been with the Town for seven years, and is advanced in many aspects of the job including equipment maintenance. He also holds a variety of certifications. Like Director Boerner, Joey is an active member of the Cedarburg Fire Department.

Additionally, the town hired Nate Jensen and Mike Czaicki over the winter to bring the Town crew back to full staffing levels.



2019 SEASON STARTS IN APRIL

2019 has seen a record number of participants for open registration, setting up a great season for all levels of play.

Baseball divisions include children ages 4-13 years old. Baseball teams for ages 4-10 will play in Cedarburg, with 11-13 year old teams mixing in some travel to other local Little League programs for an interleague play experience. 2019 ROAD IMPROVEMENTS

Town Road Maintenance for 2019

The Town of Cedarburg DPW will be crack sealing, pot hole patching, and hot mix surface patching this spring. Right-of-Way ditching and shoulder maintenance will continue this year along with tree pruning and removals.

Town Road Improvements for 2020

The Town will not be resurfacing any roadways in 2019, but will continue in 2020. Roads slated for 2020 improvement are:

- Cedar Creek Pkwy from STH 60 to Glenbrook Drive
- Sherman Road from CTH Y east toward Horns Corners Road 2,500 feet.

WIS Hwy 60 Milling and Overlay including Roundabout at Grandville Delayed!

TOWN ADMINISTRATOR'S DESK: Curbside Recycling


Our programs continued success relies on Town residents making the right choice to drop an item in your refuse cart or your recycling cart. Each item you choose to deposit in your refuse cart is another item that gets weighed at the landfill, billed to the Town of Cedarburg, and dumped/buried in the landfill.

Recycling curbside couldn't be any easier and almost all items can be recycled, below is a list of those items:

Items You CAN Recycle Curbside

- ALL plastic bottles and containers
- ALL glass bottles and jars
- ALL numbered Polystyrene packaging (Styrofoam)
- Junk mail, office & school paper, phone books, books, magazines & newspapers
- Chipboard, boxboard, brown paper bags and cardboard
- Aluminum foil, cans and empty aerosol cans
- Paper cardboard, dairy and juice containers

Items You CAN'T Recycle Curbside



- Food waste or liquids
- Plastic bags
- No foam products that aren't numbered
- Light bulbs and other hazardous material

Here are a few things to keep in mind:

Cart Ownership - These carts are the property of Waste Management and not the home owner. In the event you were to move, the recycling cart stays with the home.

Additional Carts/Exchanges - At any time a resident feels the cart they have isn't sufficient in size to handle your recycling needs, Waste Management will deliver a second 64/96 gallon cart to you for no additional charge. Please contact Waste Management @ 1-888-960-0008.

SUPERVISOR PIPKORN CONTINUED

To properly maintain our Town's 120 lane miles, 6 lane miles per year should be reconstructed at a cost of about \$100,000 per lane mile. In order to establish which roads merit the most attention, we teamed up with the Southeastern Regional Planning Commission between 2016-2018 to survey transit systems in our Town. Upon consideration of public appeals, data analysis, and the general consensus of our Board, we will first be targeting stretches of road (such as Sherman Road) and those in residential areas (such as Stonefield Drive) where potholes and fractures elevate accident rates and diminish the historic charm of our Town. Our selection of roads is based on a diagnostic model for road condition. The 4 key factors used for evaluating roads are: 1. Pavement Surface Evaluation and Rating (PASER) 2. Average daily traffic (ADT) 3. speed limit versus condition (higher speed limits pose a higher risk for collisions) 4. Density o f population. By using this data, the Town has located segments of road that require treatment the most. We have generated a long-term plan that reaches 2023, with each year addressing different set of roads within the Town. This year we will begin roadwork to lay a workable foundation for future undertakings. This will consist of general roadway maintenance: crack filling, asphalt patchwork, and shoulder repairs. In 2020, we will begin targeted renovations, starting with Sherman Road and Stonefield Drive, for a sum of 2.8 road miles at a projected \$ 280,000 cost. In 2021, we look towards Lawndale Drive, and Ann Marie Drive, 1.4 road miles at \$195,000. In 2022, we plan on reconstructing Covered Bridge Road, Grey Log Court, Oakdale Court, and Cedar Sauk Road/Kings Court, 3.6 road miles at an estimate of \$ 330,000.

Finally, in 2023, we will do Brandt Drive and Coral/Flagstone Drive, 1.9 road miles for around \$195,000. Each budget projection accounts for road construction materials as well as labor costs. Additionally, the 2019 budget has a provision for \$150,000 of future road construction.

As a Board, we believe this budget increase far outweighs the consequences of neglected roads. Especially in a rural area such as our Town, road transportation is the backbone of prosperity, and I look forward to seeing our Town flourish for years to come. Whether it be a commute to work, a weekend visit to a friend's, or the Fourth of July Parade, roads run a top priority for the Town Board and certainly for the Town's citizens as a whole.

Typical duties of this temporary, part-time position include: mowing lawns at Town Hall, Town parks, and bike paths; landscape maintenance; baseball field preparation; and some light building maintenance. Applicants must be at least 18 years of age and possess a valid driver's license. Length of employment will not exceed 12 weeks.

Upon full completion, the Korb Sports Complex will offer: four (4) 200 foot fields for boys baseball and girls softball, four (4) Tee Ball fields, three (3) full-size football/ soccer/ lacrosse fields and Walking/cross country skiing trails.

TOWN CODE

What Can I Burn?

As fall rapidly approaches, it's important to review what is authorized to be burned within the Town of Cedarburg. Per our Town Code 839-29 *Burning; It shall be unlawful to burn or bury solid waste and recyclables by residential and nonresidential sectors and at construction sites, except open burning shall be permitted of clean wood (defined as any wood that has not been chemically treated in any way) and paper products and diseased vegetation, such as but not limited to anthracnose, to control the spread of such vegetation.*



Please remember that burning green leaves, grasses, and other green vegetation not only affects your neighbors' next door and down the street, but is also illegal in the Town. Leaf smoke can irritate the eyes, nose and throat for healthy adults. It can be much more harmful to small children, the elderly, and people with asthma or other lung or heart diseases. The Town offers a compost drop off at Town Hall for all leafy yard debris, as well as brush collection service that you can sign up for on the Town Website at <http://rrc.town.cedarburg.wi.us/>.



Ever wonder if a permit was needed for a project you wanted to complete? A permit is not needed for the following: fence, roof re-shingle if there's no rafter work, tennis court, kid's playset (but must be 10' from property line). FIRE STATION POLLING LOCATION MOVING TO CIRCLE B

Town Hall Polling Location is Not Moving

Polling locations are open from 7am-8pm on Election Day. Electors living in Wards 1-4 vote at Town Hall located at 1293 Washington Avenue next to Kwik Trip.



Starting with the upcoming April 2nd election, the polling place for voters in Wards 5-10 that have voted at the Fire Station will now vote at Circle B located at 6261 STH 60 one mile east of Five Corners.

Why the change? Circle B has more ample parking, safer traffic control, better parking lot lighting, all while being accessible to all voters as was the Fire Station. Vehicles should enter the Circle B parking lot off of STH 60. Vehicles should leave the polling place onto County Highway I. Visit the Town website for complete information. If you are planning on registering to vote at the polls, allow additional time to do so.

What's on my ballot?

The spring election features Chairman and Supervisor Seats 1 & 3 (elected at-large). Also on the ballot are State Supreme Court Justice, Circuit Court Judge, and school board. Please visit <https://myvote.wi.gov/en-us/> to verify you are registered, review your voter profile, and view other important voter information including all races on your specific ballot for both elections. Open Book and Board of Review

The Town has finalized when the 2019 assessment roll will be open for examination ("**Open Book**") and the **Board of Review** will be held. Open Book will occur on April 10th from 10am-noon, and the Board of Review will occur on May 1st from 5:30-7:30pm. Instructional material about the assessment, how to file an objection, and Board of Review procedures under Wisconsin law will be available at Town Hall.

New Automated Side Load Refuse Truck

The Town has taken delivery of its new 33yd Automated Refuse Truck. The operation of our new truck **with larger refuse cart grabber** requires refuse and recycling carts to be placed a minimum of 4 feet apart from each other for ease of operation. Carts that are placed tight together cannot be picked up.
