

Town Infrastructure

We are currently living in a peculiar, perhaps unprecedented, chapter of local and national history. With all the uncertainty, I wish to ensure you that the responsibilities of the Town Board have not fallen to the wayside as 2020 comes to a close. When I first became a Town Supervisor, a main mission on my mind was plain but critical: overseeing the health of our local institutions and infrastructure. Today that mission has not waivered. Myself, along with my fellow board members, continue to collaborate on solutions for urgent infrastructure issues, working within our

limited but substantive allotment of funds. I think I speak for most citizens here in the Town of Cedarburg when I say that roads should top the list of priorities for restoration.

Infrastructural health and an intimate connection to the overall health of our Town, including its citizens, businesses, and visitors. No one likes potholes, cracks, or ruts, and I certainly prefer not to do the mental calculation of which town roads I'd avoid because of precarious conditions, especially during the winter. After our Supervisors Road Tour in October, the Town Board members were not too surprised by current road conditions, We rely primarily on a PASER scale road pavement condition developed by the University of Wisconsin-Madison Transportation Information Center to inspect and evaluate pavement surface conditions. This is a 1-10 rating system. Our Town currently has over 9 miles of rated poor or failed (1-4 rating). The estimated cost to get these roads in good condition averages about \$325,000 per mile. In addition, we have 14 miles with a 5 rating, which are typically beyond maintenance and will fall into a lower rating in future years. Next up are about 20 miles of 6 rated roads. These can be maintained to prevent immediate deterioration at a cost of about \$75,000 per mile.

For any local government role, transparency with the public should be priority number one, so it is with sincerity when I say that our budget for roadwork is severely limited right now. Our approved 2021 budget has allocated \$440,000 for roads, but that amount does not keep pace with required work. In a strenuous time like this, it is impossible to satisfy every road need. Our Town Finance committee has been meeting and is continuing to meet to explore options for financing a large-scale infrastructure plan starting in 2022.

Town Board Approves 2021 Budget

On November 24th, the Town Board approved a \$2.88 million all-funds budget for fiscal year 2021. The Town tax rate does not increase, and more importantly, the budget enables the Town to continue to provide high quality services.

The 2021 budget consists of five funds, primarily funded by a property tax levy of \$1,812,457, an increase of \$17,979. The levy increase is directly attributed to the rise in assessed value from new construction. The increase in assessed value for 2020 for the Town was 0.85%, placing the Town roughly in the middle Ozaukee County communities for growth rate. The approved tax rate is \$2.49 per \$1,000 of assessed value. A home assessed for \$300,000 will pay \$750 in property taxes to the Town. The Town has a history of steady growth, and combines that with responsible long-term financial planning.

The 2021 budget increases road funding by 25% to \$440,000 next year. Avalon Lane and Ann Marie Drive will be reconstructed, and a stretch of Cedar Creek Parkway will receive a mill and overlay. The budget also includes funding for maintenance of over 1 mile of roads on River Vista Drive, Lindale Drive, Timbercrest Drive, and Romanita Court. The Town will work with a contractor to complete the maintenance with an appropriate method such as a chip seal that will address surface issues, improve ride, and seal the pavement slowing the aging process. The budget also includes \$55,000 for ash tree removal in road rights-of-way.

In terms of capital equipment, the approved budget calls for a pickup truck with lift-gate (\$65,000), used pickup truck (\$25,000), new zero-turn mower (\$25,000), and a tilting bucket for the mini-excavator (\$10,000). In whole, this is a \$125,000 investment.

Long-Term Road & Capital Planning Efforts Underway

The Town Board has heard from residents in past years requesting increased spending to address the vast Town road network. The Town has approximately 66 miles of roads, which require constant maintenance. Historically, the Town considers PASER rating, traffic count, and the number of homes on roads when selecting roads to be included in the Road Plan.

PASER is an acronym for Pavement Surface Evaluation and Rating system. It is used for visually rating the surface condition of a pavement from a scale of 1 to 10, with 1 being a pavement in a failed condition and 10 being a pavement in excellent condition.

The 2020 budget process saw much deeper discussions into the state of Town roads. An analysis of the PASER ratings demonstrated the Town has 9 miles of roads rated 1-4, which generally are beyond preservation with maintenance techniques and will need to be rebuilt. The Town also has another 34 miles of roads that fall into the 5 & 6 PASER ratings. Understanding the state of Town roads, the Finance Committee and Town Board began the process of updating the Road Plan.

April. This program meets primarily on Tuesday evenings and runs mid-August through mid-October. The program plans to include a free mini-camp with the Concordia Football Program, a personalized dry wick jersey,



and championship games played at Concordia University's football stadium. This program has divisions for kids ages 4-12.

Mask up. Lock down. Negative means good. Positive means not so good. Keep your distance. What a year we've had! On the other hand, let's look at some positives that took place in the Town this year.

Rec Program: Despite losing April and May, we had a full season of rec play at the new **Korb** Sports Complex and OHOW Fields from June through mid-October. We had a record number of registrations, especially in our Fall Ball and soccer programs. With the quality of our programs and the numbers approaching 1,000 participants, I expect continued growth that comes with having premier facilities like the Korb Sports Complex and OHOW Fields. Our programs are 100% self-funded through sponsorships and registration fees. Sincere thanks to community businesses and residents for making our programs the success they have become! sponsorship, please contact our Parks & Recreation Director, Paul Jungbauer, at Town Hall. Originally scheduled for May, the Grand Opening of the Korb Sports Complex was delayed to a blustery day in

September. Despite weather conditions, we had a great turnout and I appreciate the continued interest and support of the facility. Great to see fields full of kids and the parking lot full of cars.

Development: Compared to neighboring communities, development in the Town of Cedarburg could be considered slow, I don't think that is a bad thing. Towns fare better with slow growth and good planning. Our land use plan provides for a variety of development possibilities and zoning options suited to the typical parcel size common in the Town. The new Meadow View Estates subdivision at Sherman and Granville roads is a good example. All lots are zoned "estate" with a minimum of four acres each, accessed by private shared drives. Along with the subdivision comes the Town required fire cistern, improving our water delivery to the subdivision and also to the surrounding properties.

Cedar Creek Motor Sports major expansion is well under way. Following the design standards set forth in the Town Code, the development will be an attractive addition to the Town's Five Corners District. The team of Cedar Creek Motor Sports was a pleasure to work with at both the Planning Commission and the Town Board level.

Roads: Improvements in 2020 – one mile of Sherman Road repaved, south Beachwood Dr. resurfaced, seven miles of shouldering, 692 feet of culverts replaced, the State completed the Hwy 60 repaving and roundabout. (What a difference that roundabout has made.) Roads are among the biggest challenges for any Town, and with over 125 lane miles ours is no exception. Contracting out resurfacing and having our public works crews handling maintenance and repairs has proven to be most cost effective. Resurfacing projects slated for 2021 – Ann Marie Dr. and sections of Cedar Creek Pkwy. and Avalon Ln. Still on track for 2022 is the traffic control improvement at NN and Granville Rd.

Paul Jungbauer Takes On Growing Parks & Recreation Department

Town Recreation programming kicked off in 2010 with the launch of Cedarburg Little League. What started out as one program split between school district fields and a few Town fields, has grown to four youth programs with over 900 players held

totally on Town fields beginning in 2020. The Town park system consists of seven parks covering over 138 acres. With the opening of the 33 acre Korb Sports Complex, the Town added four full-size youth baseball/softball fields, four tee ball fields, and a multi-use field area large enough for 2 full-size soccer fields/misc. field space. The 2020 season demonstrated the growing pains associated with more fields and players, leading the Town Board to recognize the potential to promote from within, and has named Paul Jungbauer to lead Parks and Recreation. Paul has been with the Town for 6 years, and has steadily grown programming. This reconfigured position to Director of Parks and Recreation is meant to maximize efficiencies while dedicating additional time required to properly manage Town parks. PUBLIC WORKS NOTES

A Unique Year

The Public Works Department and Town Hall staff continued to provide essential services through the COVID-19 pandemic. Elections, sanitation, road maintenance, and construction were addressed with limited staff and resources. Some of the accomplishments this year include 75 ash trees cut down, 7 miles of road shoulders backfilled and graded, 692 feet of driveway and cross road culverts installed, and 16 tons of asphalt used to fill pot holes throughout the Township.



Some Friendly Reminders: Driveway Approaches

For the upcoming year, property owners and contractors planning to replace old driveways with new asphalt and concrete must apply for a driveway permit (concrete must stop short of culvert). The approach must be asphalt.

Cart Placement

Also, remember to keep your garbage carts <u>5 feet apart</u> from other carts and mailboxes to keep collection efficient. Placing them too close together makes it difficult for the trucks to grab the cart without knocking the adjacent cart over or hitting a mailbox.


Road Plan Update Process

- August 2020: the Town Board received a presentation on road maintenance techniques that improve and prolong the life of roads that are rated 5+ on the PASER scale. There is a large menu of maintenance techniques that can be applied depending upon the condition of the road. The Board directed staff to incorporate a road maintenance component in the 2021 budget.
- October 2020: the Town Board conducted a tour of Town roads, seeing what various PASER ratings look like throughout the Town to get a representative sample of actual conditions.
- **Sept.**—**Nov. 2020**: the 2021 budget process focused on increasing miles of road work, and incorporating a maintenance program back into the annual budget. The approved budget includes 2.09 miles of road work (1.25 miles of maintenance, and 0.84 miles of road paving).
- December 2020: the Finance Committee met to discuss a larger scale Road Plan update. The consensus of the Committee was to have a financial advisor produce scenarios to address the Town roads through a combination of paving and maintenance, and how the work would be financed. The Committee is scheduled to meet when the analysis is ready in spring. The analysis is meant to be holistic (include other capital items).
- Next Steps: Finance Committee will meet to review options, determine the scope of work, and direct staff.



Hoarding and Fire: Reducing the Risk

Do you have a person in your life who may be a hoarder? Hoarding is a condition where a person has persistent difficulty discarding personal possessions. The large amount of possessions fill the home and prevent the normal use of the space. Living space becomes cluttered. It may be unusable. Hoarding brings distress and emotional health concerns.

Why Hoarding Increases Fire Risks

- Cooking is unsafe if flammable items are close to the stove or oven.
- Heating units may be too close to things that can burn. They might also be placed on unstable surfaces. If a heater tips over into a pile, it can cause a fire.
- Electrical wiring may be old or worn from the weight of piles. Pests could chew on wires. Damaged wires can start fires.
- Open flames from smoking materials or candles in a home with excess clutter are very dangerous.
- Blocked pathways and exits may hinder escape from a fire.

How Hoarding Impacts First Responders

- Hoarding puts first responders in harm's way.
- Firefighters cannot move swiftly through a home filled with clutter.
- Responders can be trapped in a home when exits are blocked. They can be injured by objects falling from piles.
- The weight of the stored items, especially if water is added to put out a fire, can lead to building collapse.
- Fighting fires is very risky in a hoarding home. It is hard to enter the home to provide medical care. The clutter impedes the search and rescue of people and pets.

How Can You Help Reduce the Risk of Fire Injury

- When talking to a person who hoards, focus on safety rather than the clutter. Be empathetic. Match the person's language. If they call it hoarding, then you can call it hoarding.
- Help the residents make a home safety and escape plan. Stress the importance of clear pathways and exits. Practice the plan often. Exit routes may change as new items are brought into the home.
- Install working smoke alarms in the home. Test them at least once a month.
- Reach out to community resources. Talk to members of the fire department to alert them of your concerns. They may be able to connect you with members of a hoarding task force for additional help.


