RESOLUTION #2025-4

"A Resolution Authorizing the Creation of a Joint Bicycle & Pedestrian Facilities Ad Hoc Committee of the City of Cedarburg and Town of Cedarburg"

WHEREAS,

the City of Cedarburg Common Council and Town of Cedarburg Board agree to the creation of an informal advisory Joint Bicycle & Pedestrian Facilities Ad Hoc Committee ("Committee"); and

WHEREAS,

the mission of this ad hoc committee could include completing an evaluation of City, Town, and interconnecting area bicycle and pedestrian-related facilities, establishing a framework for improving that infrastructure, researching ideas and options for potential connections, making recommendations on policies, projects, and initiatives to enhance safety, accessibility, and connectivity, exploring grant opportunities, engaging the community in developing a long-term plan to promote walking and biking routes, encouraging intergovernmental cooperation with neighboring Ozaukee County communities/Ozaukee County, and making periodic reports to the City of Cedarburg Common Council and Town of Cedarburg Board on findings in our Community; and

WHEREAS,

the ad hoc committee will be comprised of no more than two City of Cedarburg staff members, two Town of Cedarburg staff members, one Cedarburg Police representative (nonvoting member), and no more than six community advocate members, total, from the City and Town who have sufficient knowledge, expertise, and experience to provide thoughtful analysis of the issues affecting bicycle and pedestrian amenities. The City and Town shall each appoint a maximum of 3 community advocate members, one from each the Town and City that is a voting member. If elected officials are appointed, one will come from the City and one from the Town (if either the City or the Town chooses not to appoint an elected official, the other will not appoint one either); of the total membership, three from the City and three from the Town will be voting members, and

WHEREAS,

the Chairperson of the Committee shall be elected by majority vote of the members of the Committee at the first meeting of the Committee. The members shall also elect a vice-Chair at the first meeting, to serve as chair of the Committee in the absence of the Chairperson.

WHEREAS,

the City of Cedarburg Common Council will be responsible for appointing the City members. The Town of Cedarburg Board will be responsible for appointing the Town members; and

WHEREAS,

voting on items specific to the Town or City will be made by respective voting members of the Town or City, voting on potential connection points

will be made by all voting members, and any recommendations specific to the Town or City or potential connection points will be taken back to the Town and City elected governing bodies by their respective staff members for consideration and potential incorporation into new or existing plans at the direction of the elected officials; and

WHEREAS,

this newly formed Joint Bicycle & Pedestrian Facilities Ad Hoc Committee will be considered temporary in nature and will dissolve upon the completion of the creation and approval of independent or joint City/Town Bicycle and Pedestrian Plan(s), unless terminated sooner by action of the Town Board; the committee will have no budgeted funds assigned to it initially; and

WHEREAS,

this resolution shall become effective upon its passage by the Town of Cedarburg Board of Supervisors.

THEREFORE, BE IT RESOLVED, that the Town Board of Supervisors of the Town of Cedarburg does hereby approve and authorize the creation of this Joint Bicycle & Pedestrian Ad Hoc Committee in accordance with this resolution.
