RESOLUTION #2026-2

"A Resolution to Establish a Schedule of Cash Deposits to be used with the Issuance of Town Citations"

WHEREAS, the Town of Cedarburg ("Town") is a political subdivision as a body corporate and politic within Ozaukee County, Wisconsin;

WHEREAS, Sec. 27-3 of the Town Code provides that, "[t]he cash deposits for the various ordinances for which a citation may be issued are as established on the schedule of cash deposits adopted by the Town Board, a copy of which is on file with the Town Clerk."

NOW THEREFORE, BE IT RESOLVED by the Town Board of the Town of Cedarburg, Ozaukee County, Wisconsin, does hereby establish the following Schedule of Cash Deposits for Use with Citations Issued as follows.

SECTION / ORDINANCE	FORFEITURE	CASH DEPOSIT
§ 95-6 C. Animals at Large	Not less than \$25 not more than \$100 for the 1 st violation/ \$50 and not more than \$200 for subsequent violations	\$50 plus applicable court costs for 1 st violation / \$100 plus applicable court costs for subsequent violations.
§ 95-12. Barking Dogs	Not less than \$25 not more than \$100 for the 1 st violation/ \$50 and not more than \$200 for subsequent violations	\$50 plus applicable court costs for 1 st violation / \$100 plus applicable court costs for subsequent violations.
§ 237-2. Firearms and Explosives, including unlawful discharge	Not less than \$200 for each Offense	\$100 plus applicable court costs
§ 246-4 & 8. Junked Vehicles and Appliances	Not less than \$25 nor more than \$500 for 1 st Offense/ \$50 nor more than \$1,000 for 2nd or subsequent offense.	\$75 plus applicable court costs for 1 st violation / \$150 plus applicable court costs for subsequent violations.
§ 273-29. Burning and Dumping	Not less than \$10 nor more than \$1,000 for each violation	\$100 plus applicable court costs
§ 320-115. Outside Storage of Firewood	Not less than \$25 nor more than \$500 for 1 st Offense/ \$50 nor more than \$1,000 for 2nd or subsequent offense.	\$75 plus applicable court costs for 1 st violation / \$150 plus applicable court costs for subsequent violations.

Deposits shall be made in cash, money order, certified check, or other approved forms of payment to the Ozaukee County Clerk of Courts who will provide a receipt thereof.

In the absence of a scheduled or statutorily mandated deposit amount for a particular violation, the deposit amount shall be \$50 plus applicable court costs for a first violation, and \$100 plus applicable court costs for subsequent violation(s).


Any Resolution in conflict with this Resolution is hereby repealed.
