



IN THE NAME AND BY THE AUTHORITY OF THE TOWN OF CEDARBURG, WISCONSIN

ORDINANCE NO. 2026-4

An Ordinance to Amend: Section 16-7 Landmarks Commission; Change to Composition.

WHEREAS, the Town of Cedarburg is a body corporate and politic; and

WHEREAS, the Town currently regulates Commission composition under Chapter 16: Boards, Commissions and Committees; and

WHEREAS, the Town Board has determined that additional members will promote the public health, safety, welfare and comfort of the general public and the Town, and has directed that the Ordinances of the Town of Cedarburg be amended accordingly.

NOW, THEREFORE, BE IT ORDAINED by the Town Board of the Town of Cedarburg, Ozaukee County, Wisconsin, that Section 16-7, of the Town of Cedarburg Code of Ordinances is hereby amended to read as follows:

§ 16-7 Landmarks Commission.

A. Composition; terms. The Landmarks Commission shall be composed of ~~seven~~nine qualified persons who are competent and informed in the historical, architectural and cultural traditions of the community. All Commissioners shall be appointed by the Town Chairperson, subject to confirmation by a majority vote of the Town Board. ~~Four~~Five members shall be appointed for three-year terms at the May April Town Board meeting of odd-numbered years, and ~~three~~four members shall be appointed for three-year terms at the May April Town Board meeting of even-numbered years. The Commission chairperson shall be appointed by the Town Chairman with the majority approval of the Town Board. A vacancy occurring in the membership for any cause shall be filled by a person appointed by the Town Chairperson and confirmed by a majority vote of the Town Board for the unexpired term. The members of said Commission shall receive no compensation except for expense reimbursement sustained in carrying out their duties and as authorized by the Town Board.

B. Duties. In addition to those duties specified in Chapter 186 of this Code, the Commission shall:

(1) Actively work for the passage of enabling legislation which would permit the granting of full or partial tax exemptions to properties it has designated under the provisions of Chapter 186 of this Code.


(2) Work closely and keep in communication with the City of Cedarburg Landmarks Commission, Ozaukee County Historical Society and State Historical Society of Wisconsin.

- (3) Work closely with the State of Wisconsin liaison officer and the Governor's liaison committee for the National Register of Historic Places of the United States National Park Service in attempting to include such properties hereunder designated as landmarks or landmark sites on the Federal Register.
- (4) Work for the continuing education of the citizens of Cedarburg about the historic heritage of this Town and the landmarks and the landmark sites designated under the provisions of this Code.
