**ORDINANCE NO. 2026-6**

**An Ordinance to Amend Chapter 232 Parks & Recreation, Relating to the use of grills within the Korb Sports Complex, Orthopaedic Hospital of Wisconsin Fields and other Park and Recreation Facilities, of the Town of Cedarburg Code of Ordinances**

**WHEREAS,** the Town of Cedarburg regulates activities related to Parks and Recreation within the Town of Cedarburg, Wisconsin; and,

**WHEREAS,** the Town promotes the public health, safety, welfare and comfort of the general public by protecting the parks, parkways, recreational facilities and conservancy areas within the Town from injury, damage or desecration; and,

**WHEREAS,** the Town has constructed the Korb Sports Complex located at 8555 STH 60 and the Orthopaedic Hospital of Wisconsin Fields located at 1220 Five Corners Drive to provide facilities for active youth and adult recreation;

**WHEREAS,** the Town Board has determined that allowing the use of propane grills promotes the enjoyment of events held at Town recreation facilities and enhances comfort of the general public at said events and allows for the support of local youth organizations.

**NOW, THEREFORE, BE IT ORDAINED** by the Town Board of the Town of Cedarburg, Ozaukee County, Wisconsin, that the following portions of Chapter 232 Parks & Recreation of the Town of Cedarburg Code of Ordinances are hereby amended to read as follows:

**§ 232-2 Korb Sports Complex & Orthopaedic Hospital of Wisconsin Fields regulations.**

A. Purpose and definition. In order to provide for active recreational activities, the Town constructed the Korb Sports Complex and Orthopaedic Hospital of Wisconsin Fields. In order to protect these facilities from injury, damage or desecration, these regulations are enacted. The terms "Complex and OHOW Fields," as hereinafter used in this subsection, shall include all grounds, structures, watercourses and amenities which are located within the Korb Sports Complex and Orthopaedic Hospital of Wisconsin Fields.

(8) Making of fires. ~~No person shall start, tend or maintain a fire in the Complex and OHOW Fields. The use of personal grills is prohibited.~~ No person shall start, tend, or maintain a fire in the Complex and OHOW Fields, except in personal propane grills following the issuance of a grilling permit issued by the Director of Parks & Recreation, or their designee. Personal propane grills shall be used only in designated grilling areas. The use of personal propane grills are permitted provided lawns and vegetation are not endangered. Unburned fuel, grease, char and ashes shall be disposed of in such a manner as to prevent fire or damage to any park. Personal propane grills must be at least 10 feet from any structure, fence, tent, tree and parking lot. Making of a fire in any other means other than the use of a personal propane grills in the designated grilling areas is strictly prohibited.


(a) Grilling permit for the Complex and OHOW Fields. A grilling permit is required for the use of personal propane grills in designated grilling areas of The Complex and OHOW Fields. All applicants applying for a grilling permit must provide a refundable deposit of \$200 and a certificate of insurance for comprehensive general liability insurance denominated not less than \$1,000,000 in the aggregate and not less than \$500,000 for any single occurrence naming the Town of Cedarburg as an additional insured. The deposit shall be returned if cleanup or repair by the Town is not required. All applicants applying for a grilling permit must pay the application fee listed on the Annual Fee Schedule approved by the Town Board.
